### OFFICE ORDER

Consequent upon attaining the age of superannuation, Dr. K. Nirmal Babu, Director, ICAR-Indian Institute of Spices Research, Kozhikode, shall stand retired from the Council's service with effect from 31.05.2020 (A.N).

Dr. K. Nirmal Babu is also allowed encashment equivalent of leave salary for the unavailed earned leave, if due at his credit, on the date of his retirement, subject to a maximum of 300 days under Rule 39(2)(a) of CCS(Leave) Rules, 1972. He may also be allowed payment of the amount of GPF at his credit as per rules. Dr. K. Nirmal Babu is clear from vigilance/disciplinary angles as on date.

Further, on retirement of Dr. K. Nirmal Babu on 31.05.2020, the Competent Authority has decided to assign acting charge of the post of Director, ICAR-Indian Institute of Spices Research, Kozhikode to Dr. Santhosh J.Eapen, Head, Division of Crop Protection, ICAR-IISR, Kozhikode in addition to his own duties and without payment of any extra remuneration, till the post of Director, ICAR-IISR, Kozhikode is filled up on regular basis or until further orders, whichever is earlier.\*

Dr. Santhosh J.Eapen shall exercise all administrative and financial powers (except statutory powers) as delegated to the Directors of ICAR Research Institutes by the Council from time to time.




